1. Introduction

The UWW Anti-doping program is managed by the General Affairs Department (in collaboration with the Development Department with regards education and outreach) and the Medical & Anti-doping Commission.

The Anti-doping program consists of the following:

- Testing (in and out-of-competition)
- Results Management (positive cases, whereabouts failures)
- Therapeutic Use Exemptions
- Education & Outreach

2. Testing conducted by UWW in 2018

As **Testing Authority**, UWW and the 2018 event organizers have planned and carried out the following number of tests. This breakdown does not include the testing performed by National Anti-doping Organizations under their own program.

4. Therapeutic Use Exemptions

The UWW Therapeutic Use Exemption Committee (TUEC) is composed of three doctors from the Medical & Anti-doping Commission (Dr Marc Demars - FRA - chairman, Mika Lehto - FIN - Kohei Nakajima - JPN) and reviews all TUE applications of international level Wrestlers. The Chairman of the Medical Commission may be called to review a TUE application where potential conflicts of interest arise.

In 2018, the TUEC reviewed fifteen (15) Therapeutic Use Exemptions: nine (9) were approved, five (5) were recognized and one (1) was denied.

5. Education and outreach

Education and outreach is part of the anti-doping program and is essential to ensure Wrestlers and Coaches acquire knowledge about anti-doping rules as well as the dangers of doping.

In collaboration with the Development department as well as several National Anti-doping Organizations (NADOs), education and outreach activities were organized during championships, [More Than Medals camps](#) and Coach courses (Level 1).

As part of UWW’s policy of reduction of financial sanctions imposed for anti-doping rules violations, the National Wrestling Federation of Algeria held a seminar attended by 40 Wrestlers and 40 Athletes Support Personnel, which allowed the reduction of a previous fine imposed for doping to be reduced by half. The Iran Wrestling Federation did the same by convening 400 wrestlers for a [seminar on anti-doping in January 2018](#).
